Visa requirement for nationals of Australia, Canada and the United States postponed to January 2024

Executive summary

Effective 10 January 2024, Australian, Canadian and US nationals will be required to obtain a visa prior to entering Brazil for business, tourism and other purposes.

Key developments

The new visa requirement was previously scheduled to go into effect on 1 October 2023. As announced previously, nationals of these three countries who arrive in Brazil on or after 10 January 2024 will be required to apply online for, and obtain, a visitor visa prior to travel. Impacted individuals will be able to file applications online starting in early/mid December 2023.

Impact on employers

Employers who sponsor or deploy business travelers from these three countries to Brazil may plan accordingly, as the new visa requirement is expected to impact costs and timing in connection with related business travel.
