Suspension of visa waivers for Brazilian and Venezuelan citizens

Executive summary

Citizens of Brazil and Venezuela must now obtain visitor visas prior to entering into Mexico as visitors.

Key issues

The Mexican Government recently suspended Brazilian and Venezuelan citizens' eligibility to obtain visa waivers and enter into Mexico using only their valid national passports. Citizens of Venezuela who seek to enter Mexico as visitors (by air, land or sea) are now required to apply for and obtain a visitor visa from the Mexican Consulate with jurisdiction over their home country or place of residence.

Citizens of Brazil who seek to enter into Mexico for business or tourism, by land or sea, are similarly required to obtain a visitor visa from a Mexican Consulate prior to travel. Brazilian citizens who enter Mexico as visitors by air can either obtain a visitor visa from a Mexican Consulate or an electronic travel authorization from the Mexican immigration authorities prior to travel.

Notwithstanding the above, Brazilian and Venezuelan citizens remain eligible to enter into Mexico as visitors without a visitor visa or electronic travel authorization, provided they hold:

- Permanent resident status in Canada, Colombia, Chile, Japan, Peru, the United Kingdom, the United States of America or any of the Schengen Area member states
- A valid visa (e.g., tourist visa, resident visa) issued by Canada, Japan, the United Kingdom, the United States of America, or any of the Schengen Area member states

All travelers, including Brazilian and Venezuelan visitors who enter into Mexico by air, must complete an <u>online questionnaire</u> 12 hours prior to travel, maintain an electronic copy of the questionnaire confirmation and be prepared to present the same at the time of boarding. As of the time of this writing, foreigners entering into Mexico are not required to get tested for COVID-19 prior to travel or upon arrival. While they are advised to quarantine for 14 days on arrival, this is not a mandatory requirement.

The Mexican Government has not announced specific entry rules for recovered persons (i.e., individuals who previously tested positive for COVID-19 and have made a full recovery and are asymptomatic at the time of travel). In general, with limited exceptions, recovered persons are subject to the same rules as travelers who never tested positive for COVID-19.
