## Eligibility criteria

The nominee must be a Malaysian or Malaysian Permanent Resident (MyPR card holder) who is either:

- ▶ An owner-manager primarily responsible for the recent performance of a privately-held company that has at least two years of audited accounts; or
- ▶ A founder of a listed company who is still active in top management and who still retains a significant stake in the company.

## Categories

### Emerging

Nominees in this category should be aged 35 or under at the close of nomination or the business is between 3-5 years old.

### Technology

Entrepreneurs who are developers, providers and/or promoters of technology, digital and multimedia products and services.

### Woman

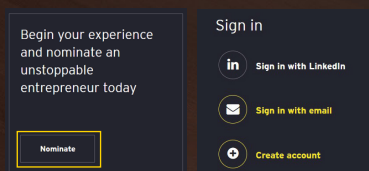
This category recognizes and honors the accomplishments of outstanding women entrepreneurs in building and leading successful businesses.

### Master

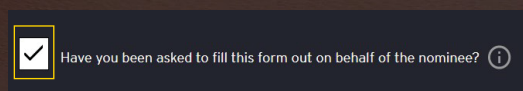
Entrepreneurs who have made a sustained contribution to the success of one or more businesses over an extended period; businesses founded more than five years ago.
