Serbian Government recommends to employers to fully remunerate employees in self-isolation and those who are infected



During yesterday's session, Serbian Government recommended to all employers to remunerate in full their employees who are in self-isolation or are infected with COVID-19, due to direct exposure to risk in performing their work obligations.



The said recommendation is not legally enforceable.
