**Updates in relation to HC/SUM 1537/2023 (“SUM 1537”), HC/CWU 94/2023 (“CWU 94”) and HC/SUM 4010/2022 (“SUM 4010”)**

Dear Sir/ Madam

We refer to the Fortieth Circular dated 8 June 2023.

As you are aware, the hearing for SUM 1537 (*i.e.*, the application to discharge the IJMs), CWU 94 (*i.e.*, the application to wind up the Company) and SUM 4010 (*i.e.*, the laptop application) has been fixed on 7 August 2023, Monday, 10am (the “**Hearing**”).

We are writing to inform that the Court has given the following directions:

1. The Hearing will be conducted as a Zoom webinar.
2. Those who may be affected by the orders sought in SUM 1537, CWU 94 and SUM 4010 and wish to attend the Hearing must register with the IJMs’ solicitors, WongPartnership LLP at [Project.Interstellar@wongpartnership.com](mailto:Project.Interstellar@wongpartnership.com) by 17 July 2023, Monday, 4pm with the following details:
  - a. the party’s full name, identification number / passport number, and email address registered with the Company;
  - b. the capacity in which the party wishes to attend the hearing (e.g. as a creditor);
  - c. the name(s) of the party’s solicitor(s) attending the hearing (if any), and the party’s solicitors’ firm (if any);
  - d. the party’s position on each of the applications being heard, namely SUM 1537, CWU 94 and SUM 4010 (*i.e.* support / oppose / no position); and
  - e. if the party is a legally unrepresented corporate creditor, the letter of authorisation (if any).
3. All registrants for the Hearing should receive a Zoom notification with the required log in details for the Zoom webinar before the Hearing. Each registrant must log in using a Zoom account one hour before the Hearing is scheduled to commence (*i.e.* by 9am on 7 August 2023). Only one device can be used by each who has registered to attend the Hearing.
4. Attendees are to note that in relation to the Zoom webinar format of the Hearing:
  - a. attendees will not be allowed to address the Court or turn on their cameras until and unless the Court approves a request that is typed into the webinar “chat” with a synopsis of what the attendee wishes to address the Court on;
  - b. the Hearing will be recorded by the Court;
  - c. watermarking technology will be used; and
