**HODLNAUT PTE. LTD. (IN LIQUIDATION) (THE “COMPANY”)
URGENT UPDATE REGARDING SPOOFING OF HODLNAUT WEBSITE AND TELEGRAM
CHAT GROUP**

Dear Sir / Madam,

We refer to the subject matter.

It has come to our attention that a Telegram chat group named “Hodlnaut Official Channel” (associated with the Telegram handle @hodlnautofficialchannel) has circulated an announcement titled “Launch of Restructured Hodlnaut 1.0” which offers users the opportunity to purportedly sign up for an account with the relaunched Hodlnaut 1.0 (using the same details for their existing accounts with the Company) at the website <http://hodl-naut.com/>. The announcement also requested that users deposit a minimum sum of \$200 in order to activate their account in Hodlnaut 1.0.

We wish to inform all users that the Telegram channel “Hodlnaut Official Channel”, Telegram handle @hodlnautofficialchannel, and the website <http://hodl-naut.com/> are **not the bona fide Telegram chat group / channel and website of the Company.** They are **not managed and controlled by the Liquidators of the Company.**

We urge all users to be vigilant and ensure that the correct URL is reflected when accessing the Company’s website. The Company’s official website is <http://hodlnaut.com/>. The illegitimate website <http://hodl-naut.com/> spoofs the Company’s official website and contains striking similarities to the Company’s official website.

It is likely that the “Hodlnaut Official Channel” Telegram channel and the website http://hodl-naut.com were created by malicious actors to scam and / or defraud users. Users should not engage with the channel or website. The Liquidators are currently investigating the illegitimate website and Telegram channel and intend to lodge a complaint / report with the necessary authorities to investigate the matter and take down these platforms.

To reiterate, the Company has suspended all withdrawals, token swaps and deposits on 8 August 2022 and was subsequently placed into liquidation by the High Court of Singapore on 10 November 2023. In view of the liquidation of the Company, the Company has ceased operations and there would be no restructuring of the Company. For the avoidance of doubt, the Liquidators will also not request for users to open an account or deposit funds with the Company.

Users are advised not to provide any personal information to any third-party individuals or platforms claiming to be operating or managing the Company. To this end, please do not hesitate to reach out to us at hodlnaut@sg.ey.com if you are uncertain whether a third-party individual is from the Liquidators’ office or if a third-party platform is managed and controlled by the Liquidators.
