- 4. Parties are to exchange, e-file and tender to Court their written submissions (limited to 35 pages including cover and index pages) and bundle of authorities for SUM 1918 and SUM 1938 by 30 September 2024, 4pm;
- 5. The half-day hearing for SUM 1917 is scheduled before Justice Aedit Abdullah on <u>30 September 2024, 10am</u>; and
- 6. The half-day hearing for SUM 1918 and SUM 1938 is scheduled before Justice Aedit Abdullah on 7 October 2024, 10am.

For avoidance of doubt, nothing herein shall be construed as an admission by the Liquidators and/or the Company of any outstanding sums which may be due and owing by the Company to you.
