# HODLNAUT PTE. LTD. (INTERIM JUDICIAL MANAGERS APPOINTED BY COURT) (THE "COMPANY") Updates in relation to HC/SUM 1537/2023 ("SUM 1537"), HC/CWU 94/2023 ("CWU 94") and HC/SUM 4010/2022 ("SUM 4010")

Dear Sir/ Madam

We refer to the Thirty-Fourth Circular dated 25 April 2023 and the Thirty-Seventh Circular dated 24 May 2023.

#### 1. <u>SUM 1537 – The Discharge Application and CWU 94 – The Winding-Up Application</u>

We are writing to provide an update on the case conference for SUM 1537 (*i.e.*, the application to discharge the IJMs) and CWU 94 (*i.e.*, the application to wind up the Company), which was held before the learned Assistant Registrar Karen Tan at 11am on 1 June 2023 (the "**Case Conference**").

During the Case Conference, counsels for both Mr. Simon Eric Lee and Mr. Zhu Juntao confirmed on record that they intend to oppose both the Discharge Application and the Winding-Up Application.

In this regard, the Court directed the following timelines:

- a. Parties which are intending to object to SUM 1537 and CWU 94 are to file their affidavits by <u>30 June</u> <u>2023, Friday, 4pm</u>.
  - (i) A case conference has been set for <u>6 July 2023, Thursday, 11am</u>, and is to be re-fixed once the affidavits are filed on 30 June 2023.
- b. The IJMs are to file their response affidavits by <u>21 July 2023, Friday, 4pm</u>.
- c. 1 set of submissions and bundle of authorities for both SUM 1537 and CWU 94 are to be filed by <u>31</u> <u>July 2023, Monday, 4pm</u>.
- d. The hearing for SUM 1537 and CWU 94 is tentatively set for the full day on <u>7 August 2023, Monday</u>, which the Court will confirm on a later date.

#### 2. <u>SUM 4010 – The Laptop Application</u>

As mentioned in the Thirty-Fourth Circular, SUM 4010 will be heard together with the winding up. In this regard, SUM 4010 will be heard tentatively on 7 August 2023.
