Updates in relation to HC/SUM 3660/2022 ("SUM 3660") and HC/OA 451/2022 ("OA 451")

Dear Sir/ Madam

We refer to our Second Circular, Fifth Circular, and Seventh Circular dated 10 September 2022, 6 October 2022, and 20 October 2022 respectively.

As stated in our Fifth Circular, Mr. Simon Eric Lee had, on 30 September 2022, filed an affidavit ("**1st Affidavit of Mr. Simon Eric Lee**") in support of his application seeking, amongst others, an order that Ee Meng Yen Angela and I be removed from office as the Interim Judicial Managers ("**IJMs**") of the Company ("**SUM 3660**").

If the affidavits have been filed, then the case conference will be re-fixed. If the case conference is to proceed, the IJMs are to provide the attendance list by 28 November 2022 at 12pm.
