
Flybe Limited (in administration) ("the Company" or "Flybe")


hereby give notice that the administration has been extended by order of the court made on 2 March 2021.

The reasons for seeking the extension were to allow the Joint Administrators sufficient time to conclude their work, with the objective of achieving the best possible realisation of the company's business and assets for the company's creditors as a whole.

The work remaining is summarised below –

- (a) selling the company's remaining engines and inventory through our appointed agents, together with any other inventory that is recovered or that may become available during the course of the administration;
- (b) collecting any retained funds held in escrow, in relation to the Flybe Aviation Services Limited share sale (now collected);
- (c) liaising with debtors in relation to the outstanding amounts owing to the company and collecting in the same, and progressing other routes of recovery for the benefit of creditors;
- (d) assisting redundant employees with any claims against the Redundancy Payments Office or the company, and dealing with protective award claims and subsequent payments by the Redundancy Payment Service (which will impact and potentially create further preferential creditor claims for employees);
- (e) negotiating with landlords regarding retained leasehold premises and suppliers, including dealing with any remaining retention of title ("ROT") claims and realising any inventory subject to unsuccessful ROT claims;
- (f) calculating the Corporation Tax and VAT positions of the Company, as at the date of appointment, and for subsequent periods during the administration. Obtaining final clearances;
- (g) making distributions to the secured and preferential creditors (as applicable);
- (h) making distributions to the unsecured creditors under the prescribed part or otherwise (as applicable) and dealing with their enquiries; and
- (i) dealing with the statutory requirements of the Company's administration, including reporting to creditors as necessary; and finalising the administration including the payment of all administration liabilities.
