HF Stores Realisations Limited (formerly House of Fraser (Stores) Limited) (in Administration) ("the Company")

As you are aware, on 10 August 2018, the Company entered administration and A M Hudson, C P Dempster and C A Lewis were appointed as Joint Administrators.

Please note that C P Dempster resigned as an Administrator of the Company on account of his retirement as a Partner of EY. Mr Dempster's resignation took effect on 24 November 2023.

As creditors may recall, following creditors' consent being obtained in terms of paragraph 76(2) of Schedule B1 of the Insolvency Act 1986, the period of the Administration was extended by 12 months to 10 August 2020. Following applications to the Court of Session under paragraph 76(2)(a) of Schedule B1 of the Insolvency Act 1986, a further extension was made by 12 months to 10 February 2023 and again to 10 February 2024.

We currently anticipate that we will require to apply to the Court of Session to further extend the period of the Administration by 12 months to 10 February 2025 to allow time to:

- Continue to resolve an ongoing legal dispute with a debtor that has a large unpaid balance due to the Company relating to the pre administration period; and
- Realise the remaining assets, including ongoing rates refunds and VAT and tax refunds, for the benefit of creditors.
