## Spicers Limited ("Spicers") (in Administration) ("the Company")

As you may be aware, on 14 May 2020, Charles King and I were appointed as Joint Administrators of Spicers, the Company (the "Appointment"). The Appointment was made by the Company's directors under the provisions of paragraph 22(2) of Schedule B1 to the Insolvency Act 1986. The Joint Administrators act as agents of the Company only and without personal liability and I attach formal notice of our Appointment for your information. Please note that a connected company, OfficeTeam Limited ("OT") was also placed into administration on 14 May 2020 and Charles King and I were appointed as Joint Administrators.

As licensed insolvency practitioners, we are bound by the Insolvency Code of Ethics when carrying out all professional work relating to the Administration.

Please be advised on 14 May 2020, the 5 star brand and trademark and the stock of Spicers, were sold to Paragon Data Analytics Limited ("PDAL"). The Sale Agreement excluded stock subject to a valid Retention of Title ("ROT") claim. If you believe you have an ROT claim then please email spotsuppliers@uk.ev.com

The Company has ceased trading other than for the managed wind down of its affairs and sale of its remaining assets and on this basis please note that with effect from the date of our appointment the Company will not be responsible for payment for any goods or services delivered to the Company except against orders which bear the signature of one of the Joint Administrators, or one of our representatives. Goods and services so ordered will be paid for on normal credit terms.

If any orders placed with you by the Company prior to our appointment have not been completed, they should not be completed unless you receive written confirmation from either of us, or our authorised representative, that the goods or services are still required. Please let me have a statement of any orders placed by the Company prior to our appointment which have not yet been completed.



#### Creditors' claims

Please note that debts incurred by the Company before our appointment will rank as unsecured claims against the Company. Any sums due to the Company arising after our appointment must be paid in full and without set-off against any debts incurred by the Company prior to our appointment.

Certain debts due from the Company may be preferential in accordance with section 386 of the Insolvency Act 1986. If you consider that you have a claim in this category, please advise me immediately. If you hold any security for your claim or you consider that you have title to any assets in the Company's possession, please forward details to me as soon as possible. You may be entitled to VAT bad debt relief on debts arising from supplies more than six months old. This procedure does not involve the Joint Administrators and claims should be made directly to HM Revenue & Customs.

#### Submitting a claim
