Crawshaw Butchers Limited (in Administration) ("the Company") ("Butchers")

As you are aware, on 2 November 2018 the Company entered administration and R H Kelly and I were appointed as Joint Administrators. The appointment was made by the directors under the provisions of Paragraph 22 of Schedule B1 to the Insolvency Act 1986. The Joint Administrators act as agents of the Company only and without personal liability.

Please be advised that on 30 November 2018 a sale of certain of the Company's business and assets was completed to Loughanure Limited ("LL"). LL is not liable for redeeming any of the Crawshaw Savings Club stamps and as such, you will need to send your stamps to the Joint Administrators for redemption.

The directors of the Company set aside funds of £84,100 prior to the appointment of Administrators which the directors believe should be sufficient to repay all Savings Club stamps to customers. However, there is no record of the value of stamps held by customers and therefore the Joint Administrators need to provide adequate opportunity for all Savings Stamp club holders to apply for redemption.

Accordingly, the Joint Administrators will shortly advertise a notice requesting all customers to send their stamps to the address at the top of this letter before 31 January 2019. Once this date has passed and the total claims of customers has been calculated, a distribution of the funds available will be made by bank transfer in proportion to the total value of claims made.
