[US-Chile tax treaty advances toward ratification](#)

On 1 June 2023, the US Senate Foreign Relations Committee voted out of committee (20-1) the proposed US-Chile Double Taxation Agreement (Treaty). The next step is for the US Senate to give its advice and consent to ratification of the Treaty. Once approved, Chile would become the third Latin American country with a double tax treaty with the United States.

Costa Rica's tax authority updated the list of digital services that will incur the 13% value added tax (VAT). Beginning 1 June 2023, the VAT must be withheld when those digital services are purchased.
